The meeting will be held on *Tuesday, April 21, 2026, at 12:00 Noon.*

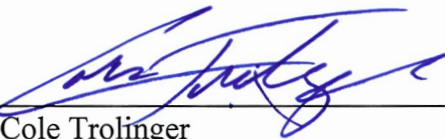
The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to or related to same:

1. Public comments;
2. Approval of the minutes of the Board meeting of March 17, 2026;
3. Bookkeeper's Report, including financial and investment reports, and authorizing the payment of invoices presented;
4. Approval of the Amended and Restated Agreement with Municipal Information Services;
5. Tax Assessor-Collector Report, including status of collections, authorizing the payment of invoices presented, and approval of installment plans;
6. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Real Property Taxes and authorize the delinquent tax attorney to pursue the collection of delinquent real property taxes beginning July 1, 2026, including the filing of lawsuits, as necessary;
7. Sales Tax Audit Report prepared by Revenue Management Services;
8. Delinquent Tax Report, including discussion regarding legal action taken by the District's delinquent tax collections attorney;
9. Landscape Management Report;
10. Engineering Report, including:
  - (a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District, and approving of related storm water plans;
  - (b) Authorizing the award of construction contracts for the construction of facilities within the District, accepting any related TEC Form 1295, and approving any related storm water permits;
  - (c) Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders in connection therewith;
    - (ii) Status of installation of streetlights along North Fry Road and Morton Road by Centerpoint Energy;

- (d) Status of proposed capital improvement plan; and
  - (e) Approval of the 0.2353 Sanitary Sewer Easement from NH Windstone LP;
11. Status of development of the approximately 4.5-acre tract of land located within the District by NH Windstone, LP, and approval of any documents in connection therewith;

  13. Discuss the Operations Advisory Committee meeting for the Wastewater Treatment Plant;
